

HOUSEHOLD RESOURCE ALLOCATION EFFICIENCY AND FAMILY WELL-BEING OUTCOMES IN ESAN WEST LOCAL GOVERNMENT AREA, EDO STATE, NIGERIA: A HOME ECONOMICS ANALYSIS

Abstract

This study examined the efficiency of household resource allocation and its impact on family well-being in Esan West Local Government Area, Edo State, Nigeria. Four research questions were raised for the study. Using a cross-sectional survey design, data were collected from 400 households selected through stratified random sampling across urban, semi-urban, and rural communities. A structured questionnaire captured socio-demographics, household income and expenditure, time and labor allocation, and indicators of well-being, including child school attendance, nutritional adequacy, healthcare access, and subjective satisfaction. Resource allocation efficiency was measured using a Household Resource Allocation Efficiency Index (HRAEI), while family well-being was assessed with a Household Well-Being Index (HWI). Data were analyzed using descriptive statistics, Pearson correlation, and multiple regression to explore the relationship between HRAEI and HWI and identify socio-demographic moderators.

The results indicate that most households operate at moderate efficiency, with higher HRAEI scores significantly associated with improved well-being outcomes ($r = .68, p < .01$). Regression analysis showed that a 10% increase in HRAEI corresponds to a 7% increase in HWI, with education and household size acting as significant moderators. Gender and age had limited influence, while cultural norms, especially women's roles in household management, shaped allocation patterns. The study highlights the need for Home Economics interventions to improve budgeting, time, and labor management skills and for policy measures supporting resource-constrained households. By linking efficiency metrics with multidimensional well-being, this research provides a practical framework for evaluating household resource management and contributes to the empirical literature on rural Nigerian household economics.

Introduction

Households are the primary units of consumption and production in society, responsible for the allocation of scarce resources such as income, time, and human capital. In developing countries like Nigeria, resource constraints are particularly pronounced in rural areas, where

families face multiple competing demands for basic needs, including food, education, healthcare, and housing. The efficiency with which households allocate these resources often determines their well-being outcomes, influencing child development, adult health, and socio-economic mobility (Adebayo & Olowu, 2021; Eze & Okafor, 2022). In Esan West Local Government Area (LGA) of Edo State, households face unique challenges related to rural livelihoods. Agriculture remains a primary source of income, yet fluctuating crop yields, market volatility, and limited access to formal credit affect household expenditure decisions. Traditional socio-cultural norms, particularly gendered roles in decision-making, influence how resources are allocated within households. Studies show that women often manage food and child-related expenditures, while men may control income from farm produce, creating potential inefficiencies that impact family well-being (Olufunke, et al., 2020).

Resource allocation efficiency refers to the degree to which households optimize the use of limited resources to achieve desired outcomes (Smith & Barrientos, 2020). Efficient households are able to balance competing needs, prioritize essential expenditures, and adopt adaptive strategies such as bulk purchasing, time-sharing, and labor allocation to maximize well-being. Conversely, inefficiency can lead to inadequate nutrition, irregular school attendance, poor health outcomes, and increased vulnerability to shocks (Carter & Nguyen, 2024).

Family well-being is a multidimensional concept encompassing physical health, educational attainment, psychosocial satisfaction, and economic security. The linkage between resource allocation and family well-being has been widely recognized in the global Home Economics literature. For example, Li, et al. (2023) found that effective household budgeting and expenditure planning in rural China improved child nutrition and educational outcomes. Similarly, studies in African contexts highlight that households with higher resource allocation efficiency demonstrate better health-seeking behavior, more consistent school attendance for children, and improved household food security (Okeke, et al., 2021; Tadesse & Ayele, 2022). Despite these insights, empirical research focusing specifically on Esan West LGA is limited. Previous Nigerian studies often aggregate data at the state or regional level, neglecting the unique socio-economic and cultural characteristics of specific LGAs (Akinyemi & Bello, 2020). This gap underscores the need for localized studies that examine how household decisions regarding resource allocation impact measurable well-being outcomes in rural communities. Understanding these dynamics can inform both Home Economics education programs and policy interventions aimed at enhancing household resilience and quality of life.

Theoretical Framework

The theoretical framework guiding this study is based on Household Production Theory (Becker, 1965) and modern adaptations incorporating efficiency metrics. Household Production Theory posits that households use resources—time, labor, and money—to produce “commodities” such as health, nutrition, and education for family members. This study operationalizes efficiency in resource allocation as the ability to maximize these outputs relative to available inputs, adjusted for socio-demographic characteristics. Thus, this study seeks to address the following central concern: How does household resource allocation efficiency affect family well-being outcomes in Esan West LGA?

Literature Review

Household Resource Allocation

Household resource allocation refers to how families distribute limited resources such as income, time, labor, and assets among competing needs. This concept is central to the fields of Home Economics, development economics, and family studies because the efficiency of allocation decisions has direct implications for household welfare outcomes including food security, health, education, and overall quality of life (Smith & Barrientos, 2020). In the context of developing countries, rural households routinely make trade-offs between immediate consumption (e.g., food) and long-term investments such as children's schooling, health care, and savings (Adebayo & Olowu, 2021; Carter & Nguyen, 2024). These decisions are shaped not only by income constraints but also by intra-household dynamics, cultural norms, and access to information.

Resource allocation processes are influenced by both structural and behavioral factors. Structural determinants include household income levels, asset ownership (land, livestock), access to markets, and availability of social infrastructure, while behavioral determinants include individual preferences, bargaining power among household members, and cultural dictates on consumption patterns (Olufunke et al., 2020; Eze & Okafor, 2022). For example, several studies in Nigeria show that households with greater female decision-making power are more likely to allocate resources to food and children's education, suggesting that gendered intra-household negotiation significantly influences allocation outcomes (Olufunke et al., 2020; Household headship research in Southeast Nigeria). However, while much research has examined resource allocation in broad terms, empirical understanding at the local level—especially using primary household data—is still limited. A convenience of more aggregated national or state level studies is that they mask crucial local socio-economic and cultural nuances that can alter allocation behavior significantly, for instance in rural agrarian communities such as Esan West Local Government Area (LGA) (Adebayo & Olowu, 2021).

Resource Allocation Efficiency and Its Measurement

Modern research transcends simple expenditure shares to focus on efficiency—the extent to which households maximize well-being outcomes given resource constraints. Efficiency analysis draws from economic theories such as Household Production Theory (Becker, 1965) and collective decision-making models which conceive households not as monolithic units but as arenas of negotiation with differentiated preferences and bargaining power. Under this view, efficiency is not just about how much is spent on food or education but how strategically resources are distributed to produce desired welfare outcomes (Carter & Nguyen, 2024).

Quantitative measures of allocation efficiency often employ Data Envelopment Analysis (DEA), stochastic frontier models, or the construction of composite indices that integrate multiple inputs (income, time, labor) and outputs (nutrition, school attendance, health access). This multi-dimensional approach helps capture efficiency beyond narrow financial metrics (Tadesse & Ayele, 2022). For instance, composite indices that incorporate expenditure ratios, time use patterns, and labor contributions have been applied in African studies to assess efficiency among rural households. This acknowledges that household welfare is not solely determined by monetary resources but also by how time and labor are allocated across productive and domestic tasks. Such indices are particularly useful in settings where informal labor and subsistence agriculture dominate the household economy, as they better reflect the holistic use of resources (Tadesse &

Ayele, 2022). Nevertheless, most African studies to date remain sectoral or narrowly focused, emphasizing agricultural or nutritional outcomes in isolation (e.g., food security, micronutrient intake) without integrating broader dimensions of well-being such as psychosocial satisfaction, education access, or health service utilization. For example, research on intra-household food allocation in rural Nigeria highlights that cultural norms often prioritize adults or male members for high-nutrient foods, leading to child malnutrition, but does not fully integrate how these patterns relate to other outcomes like schooling or health access (Blum, et al., 2022).

Family Well-Being Indicators and Multidimensional Outcomes

Family well-being is increasingly conceptualized as a multidimensional construct that encompasses physical health, educational attainment, psychosocial satisfaction, economic security, and subjective life evaluations (Smith & Barrientos, 2020; Li, et al., 2023). Traditional metrics, such as income and food security, while important, do not fully capture the varied ways household resource allocation affects quality of life. For example, adolescents' mental health and nutritional status are closely tied to household food security, but stress and psychosocial outcomes often remain under-studied in rural Nigerian settings (Folorunso, et al., 2025).

Evidence from Sub-Saharan Africa suggests that households with higher allocation efficiency report better outcomes across several domains. Okeke *et al.* (2021) found that efficient allocation correlated with improved food security and reduced morbidity in rural communities. Meanwhile, research on gendered food security gaps indicates that female-headed households often face constraints in resource allocation that negatively affect food security and, by extension, overall well-being (Household headship study, Southeast Nigeria). Despite these insights, there is no standardized well-being index widely adopted in Nigerian household studies, especially one that integrates nutrition, education, healthcare access, and subjective satisfaction within a single analytical framework. This fragmentation limits cross-study comparability and obscures the cumulative effects of allocation decisions on household welfare.

Socio-Cultural Factors and Decision-making in Nigerian Households

Socio-cultural norms deeply embed household resource allocation practices within broader systems of gender, age, lineage, and community expectations. Nigeria's predominantly patriarchal structure often assigns decision-making authority over income and major expenditures to men, while women typically manage domestic needs and chores (Olufunke, et al., 2020). This division of roles has important implications for allocation efficiency because it can either facilitate or inhibit the prioritization of essential needs like children's education or preventive healthcare.

Sociological studies also show that intra-household power dynamics and cultural food narratives influence not just what is consumed but who consumes it. For instance, children and women may receive less nutrient-rich food due to norms that privilege men in food distribution, even when household food availability is adequate (Blum et al., 2022). Additionally, cultural practices around child feeding, work roles, and educational investment further interact with economic constraints, complicating efforts to optimize allocation across competing needs. However, most sociological studies in Nigeria focus on qualitative descriptions of norms rather than quantitatively linking these norms to measurable well-being outcomes across multiple dimensions. This leaves a critical gap in understanding how specific cultural practices systematically influence the efficiency of resource allocation and resultant well-being outcomes. Despite the growth of research on household resource allocation and well-being, several important gaps remain:

1. *Lack of localized empirical studies*: Most existing research aggregates data at state or national levels, obscuring *community-specific factors* that shape allocation decisions. There is particularly limited evidence from Esan West LGA, a rural Nigerian context with unique socio-cultural and economic characteristics.
2. *Limited multidimensional analysis*: Few studies integrate resource allocation efficiency with multidimensional well-being indices that encompass nutrition, education, health access, and psychosocial outcomes simultaneously. Most existing works concentrate on single outcomes like food security or nutrition.
3. *Insufficient application of efficiency metrics*: While composite indices and frontier methods are used in other contexts, they are seldom implemented in Nigerian household studies that examine the interplay between allocation decisions and well-being outcomes across multiple domains.
4. *Under-quantification of socio-cultural mediators*: Though cultural norms are acknowledged as influential, quantitative analyses capturing how norms and intra-household power structures mediate allocation and well-being remain scarce.

This study addresses these gaps by conducting a community-level empirical analysis of household resource allocation in Esan West LGA using a structured survey. It integrates a Household Resource Allocation Efficiency Index (HRAEI) with a composite Household Well-Being Index (HWI) that covers multiple life domains. By doing so, it advances the literature by providing *quantifiable links* between allocation efficiency and multidimensional well-being outcomes in a context where such evidence is currently lacking.

Methods

This study adopted a cross-sectional survey design, which is particularly suitable for capturing a snapshot of household resource allocation patterns and well-being outcomes at a specific point in time (Creswell & Creswell, 2023). Cross-sectional surveys enable researchers to examine the relationships between independent variables (household resource allocation efficiency) and dependent variables (family well-being outcomes) across a wide range of households. By employing both quantitative and qualitative measures, the design accommodates the multidimensional nature of household behavior, capturing not only financial allocation but also time use, labor contributions, and subjective perceptions of well-being (Bryman, 2016). The choice of a cross-sectional design is justified given the study's objectives, which aim to assess efficiency, identify patterns, and examine associations rather than establish causal inferences over time. Additionally, this design is cost-effective, practical, and aligns with ethical considerations, as it minimizes intrusion into household routines while providing robust data for statistical analysis (Adebayo & Olowu, 2021).

The study population consisted of all households in Esan West Local Government Area (approximately 40,000 households) as reported by the National Bureau of Statistics (2022). To ensure that the sample accurately reflects the diversity of household contexts—urban, semi-urban, and rural—the study employed stratified random sampling. This approach divides the population into homogeneous strata based on geographical location and socio-economic characteristics, ensuring proportional representation across all community types (Kothari, 2022).

A total of 400 households were selected for the survey. The sample size was determined using Cochran's formula for finite populations, balancing statistical power and logistical feasibility. Stratification also allowed the analysis of resource allocation patterns across socio-

economic groups, facilitating insights into how context moderates household efficiency and well-being outcomes.

Data were collected using a **structured questionnaire** developed based on validated tools from prior studies (Eze & Okafor, 2022; Tadesse & Ayele, 2022). The questionnaire included sections on: *Socio-demographic characteristics*: Age, gender, household size, education level, occupation, and marital status; *Household income and expenditure*: Monthly income, proportion spent on food, education, healthcare, utilities, savings, and leisure; *Time allocation*: Hours per day dedicated to domestic chores, childcare, productive work, and leisure; *Access to social services and well-being indicators*: Educational enrollment and attendance of children, healthcare utilization, food security measures, and perceived quality of life; and *Subjective well-being measures*: Self-reported satisfaction with household economic situation, health, and social relationships using a 5-point Likert scale (1 = very dissatisfied, 5 = very satisfied).

The questionnaire was pre-tested on 20 households outside the main sample. The pre-test assessed clarity, comprehension, and reliability, resulting in a Cronbach's alpha of .82, indicating strong internal consistency and suitability for large-scale administration (Nunnally & Bernstein, 1994). The measurements of key variables are as follows:

Household Resource Allocation Efficiency Index (HRAEI): The HRAEI was constructed to quantify the efficiency of household resource use. It integrates three components:

- Proportional expenditure on essential needs (food, education, healthcare).
- Time allocation efficiency, measuring the proportion of productive vs. non-productive time use in household activities.
- Labour distribution, assessing whether household labor inputs are optimally aligned with household needs and capacities.

Each component was weighted based on expert consultation and literature guidance (Carter & Nguyen, 2024; Tadesse & Ayele, 2022). The HRAEI scores range from **0–100**, with higher scores indicating greater efficiency in resource allocation.

Household Well-Being Index (HWI): The **HWI** is a composite index designed to capture **multidimensional household outcomes**. It includes:

- *Nutrition*: Adequacy of dietary intake and food security measures.
- *Education*: Enrollment, attendance, and academic engagement of children.
- *Healthcare access*: Frequency of medical consultations and preventative care.
- *Subjective well-being*: Household satisfaction with economic and social conditions.

The HWI scores were normalized to a 0–100 scale, allowing direct comparison with HRAEI scores to evaluate correlations and predictive relationships.

Data were analyzed using IBM SPSS Statistics v29. The analytical approach included: Frequencies, percentages, means, and standard deviations to summarize socio-demographics, resource allocation patterns, and well-being indicators. Pearson correlation coefficient to examine the strength and direction of the relationship between HRAEI and HWI. Multiple linear regression to quantify the effect of resource allocation efficiency on family well-being while controlling for socio-demographic moderators (education level, household size, gender of household head). Comparison of HRAEI and HWI across urban, semi-urban, and rural strata to assess context-specific patterns. Statistical significance was set at $p < .05$, and assumptions of regression (linearity, homoscedasticity, normality, multi-collinearity) were checked to ensure robustness of findings. The methodological rigor ensures that the study provides valid, reliable, and generalizable insights into household resource allocation efficiency and family well-being in Esan West LGA.

Results

The results (Table 1) indicate that the majority of respondents were female (55%), suggesting that women play a prominent role in household management and decision-making in Esan West LGA. Most respondents were aged 36–50 years (50%), highlighting the dominance of middle-aged adults who are typically responsible for household planning, resource management, and caregiving. The most common household size was 5–7 members (52.5%), reflecting moderately large rural families. These socio-demographic characteristics are consistent with patterns observed in rural Nigerian communities, where households are often female-managed in domestic resource allocation and family sizes remain relatively large to balance labour and consumption needs. Understanding these characteristics is essential, as gender, age, and household size may be ready factors influencing the efficiency of household resource allocation and subsequent family well-being outcomes.

Research Question 1: What is the level of household resource allocation efficiency in Esan West LGA?

Household resource allocation efficiency was assessed using the Household Resource Allocation Efficiency Index (HRAEI), which integrates proportional expenditure on essential needs, time allocation, and labor distribution within households. The classification of households into low, moderate, and high efficiency levels is presented in Table 2.

The results in Table 2 indicate that 60% of households demonstrated moderate resource allocation efficiency, while 20% were classified as low or high efficiency. This suggests that the majority of households manage their resources reasonably well, but there remains potential for improvement, especially in savings behavior, labor optimization, and expenditure prioritization. The pattern observed aligns with previous studies in rural Nigerian contexts, where households face income constraints, competing household demands, and limited access to financial planning tools, factors which collectively influence efficiency (Olufunke, et al., 2020; Tadesse & Ayele, 2022). The findings underscore the importance of targeted interventions, such as financial literacy programs and resource management training, to enhance efficiency and ultimately improve household well-being outcomes.

Research Question 2: What are the family well-being outcomes in the households studied?

Family well-being was measured using the Household Well-Being Index (HWI), which captures multiple dimensions, including nutrition, educational attainment, healthcare access, and subjective satisfaction. The distribution of HWI scores among the surveyed households is presented in Table 3.

The results in Table 3 indicate that the majority of households (62.5%) reported moderate well-being, while only 15% achieved high well-being, suggesting that optimal welfare outcomes are still limited to a small proportion of households. Households with low well-being scores (22.5%) were generally associated with low HRAEI scores, highlighting that inefficiencies in resource allocation adversely affect nutrition, educational access, healthcare utilization, and overall subjective satisfaction. These findings align with prior research in rural Nigeria, which emphasizes that households with better-managed resources experience superior multi-dimensional welfare outcomes, including improved food security, child education, and healthcare utilization. The results underscore the critical role of efficient household resource management in promoting family well-being and provide a rationale for interventions targeting financial literacy, time management, and equitable labour distribution within households.

Research Question 3: How does household resource allocation efficiency affect family well-being outcomes?

The relationship between Household Resource Allocation Efficiency (HRAEI) and Household Well-Being (HWI) was examined using Pearson correlation and multiple linear regression analysis. Socio-demographic variables—education level, household size, gender of household head, and age—were included as potential moderators. The detailed results are presented in Tables 4a and 4b.

From Table 4a, a strong, positive, and statistically significant correlation was observed between HRAEI and HWI ($r = .68, p < .01$), indicating that households with higher efficiency in resource allocation tend to achieve better well-being outcomes, including nutrition, education, healthcare access, and subjective satisfaction.

The regression analysis in Table 4b indicates that HRAEI is the strongest predictor of family well-being ($\beta = .62, p < .001$), confirming that efficient household resource allocation has a substantial impact on well-being outcomes. Education level ($\beta = .14, p = .013$) and household size ($\beta = .11, p = .017$) also significantly moderate this relationship, suggesting that households with more educated heads and moderate household sizes can utilize resources more effectively to achieve better outcomes. Gender of household head and age were not statistically significant predictors in this model, although female-headed households showed a positive trend, reflecting the tendency for women to prioritize essential household needs. The model explains 49% of the variance in HWI, demonstrating that resource allocation efficiency, together with key socio-demographic factors, accounts for nearly half of the differences in family well-being across households in Esan West LGA. These findings corroborate earlier studies in Nigerian and African contexts, emphasizing that the strategic management of household income, time, and labor is critical for achieving better nutrition, education, and health outcomes.

Research Question 4: Which socio-demographic factors moderate the relationship between resource allocation and well-being?

Socio-demographic moderators examined included education level, household size, gender of household head, and age. The regression coefficients and significance levels are shown in Table 5.

Table 5 shows that education level and household size significantly moderate the impact of resource allocation on well-being. Households with more educated heads utilize resources more effectively, yielding better outcomes, while moderate household sizes optimize labor and consumption balance. Gender and age were not statistically significant moderators in this study, though female-headed households showed a positive trend toward higher efficiency, aligning with observations that women often prioritize food and children’s education in resource allocation.

Discussion

The findings of this study provide strong empirical evidence that household resource allocation efficiency (HRAEI) is a critical determinant of family well-being (HWI) in Esan West LGA. Households with higher efficiency scores consistently demonstrated better nutritional outcomes, higher rates of school attendance among children, and improved access to healthcare services. This corroborates prior studies in rural African and Asian contexts, where efficient allocation of income, time, and labor was shown to enhance multiple dimensions of family welfare (Eze & Okafor, 2022; Li et al., 2023). The strong positive correlation ($r = .68$) and the significant predictive value of HRAEI ($\beta = .72$) further affirm that households that strategically prioritize and manage resources can achieve measurable improvements in overall well-being.

The study also highlights the role of socio-demographic factors in moderating the efficiency–well-being relationship. Education level emerged as a significant moderator, with more educated household heads demonstrating higher efficiency in resource allocation. This aligns with human capital theory, which posits that education equips individuals with the knowledge, planning, and decision-making skills necessary for optimizing resource use (Adebayo & Olowu, 2021). Household size was another significant moderator; larger households face increased consumption demands and labor allocation challenges, which can reduce efficiency, whereas moderately sized households may benefit from economies of scale in labor and consumption. Gender and age were not statistically significant predictors, though female-headed households showed a positive trend toward efficiency, reflecting women's central role in managing food, childcare, and day-to-day household needs (Olufunke, et al., 2020).

The predominance of expenditure on food (45% of income) reflects households' prioritization of basic survival needs, consistent with Maslow's hierarchy of needs. Education and healthcare receive smaller proportions of the budget, which, while significant, indicate trade-offs between immediate survival and long-term investment in human capital. Low savings (6% of income) further underscores economic vulnerability and susceptibility to shocks, a pattern widely documented in rural Nigerian households (Tadesse & Ayele, 2022). Also, cultural norms and gender roles significantly shape resource allocation patterns. Women primarily manage household consumption for food and child-related needs, enhancing efficiency in these domains. However, patriarchal structures sometimes limit women's influence over income control, potentially constraining overall household financial management. These dynamics suggest that intra-household negotiation and empowerment strategies could improve allocation efficiency and well-being outcomes (Olufunke, et al., 2020; Eze & Okafor, 2022).

The findings support the application of Maslowian and household production theories in understanding resource allocation and well-being. Households first satisfy basic physiological needs (food and health) before allocating resources to education, savings, and discretionary expenditures. Moreover, the study demonstrates that quantitative efficiency measures (HRAEI) can effectively predict multi-dimensional well-being outcomes (HWI), bridging a gap in empirical studies on localized household resource management in Nigeria.

From a policy and practice perspective, the study suggests that enhancing financial literacy, promoting strategic time and labor management, and supporting education for household heads can significantly improve family well-being. Targeted interventions that empower women in household financial decision-making may further optimize resource allocation efficiency, particularly in rural contexts with entrenched socio-cultural norms. In summary, the study underscores that household resource allocation efficiency is a pivotal mechanism through which family well-being outcomes are realized, moderated by socio-demographic and cultural factors. These insights provide both theoretical and practical guidance for programs aimed at improving

welfare outcomes in rural Nigerian communities. These findings underscore the importance of Home Economics education programs aimed at enhancing resource management skills, particularly in rural areas. Policies supporting microcredit access, financial literacy, and community-based workshops can further improve efficiency and well-being outcomes.

Conclusions and Recommendations

This study demonstrates that household resource allocation efficiency (HRAEI) is a critical determinant of family well-being (HWI) in Esan West LGA, Edo State. Households with higher efficiency scores consistently exhibited better nutritional status, higher educational engagement, improved healthcare access, and greater subjective satisfaction. Socio-demographic factors, particularly education level and household size, significantly moderated the relationship between efficiency and well-being, highlighting the importance of human capital and household structure. Cultural norms, including gendered roles in household management, also influenced allocation patterns, emphasizing the role of intra-household negotiation and empowerment in enhancing efficiency. In conclusion, the findings underscore that strategic household management of income, time, and labor is central to achieving multi-dimensional well-being outcomes and that interventions at both the household and community levels are necessary to improve resource allocation practices in rural Nigerian contexts.

The following recommendations are made based on findings

- a) Home Economics Educators need to implement community-based programs to educate households on budgeting, time management, and labor allocation strategies. Such programs can enhance resource allocation efficiency and promote sustainable well-being outcomes.
- b) Financial and micro credit institutions need to facilitate access to microcredit, savings schemes, and low-interest loans to improve household resilience against economic shocks and support long-term investments in health, education, and nutrition.
- c) There is need to develop government and local authority programs targeting rural households, focusing on healthcare access, educational support, and food security initiatives to reduce constraints on resource allocation.
- d) Male household heads need to promote equitable participation in household decision-making, empowering women to contribute meaningfully to financial and consumption decisions. This can enhance allocation efficiency, particularly in child welfare and nutrition.
- e) Researchers in Home Economics field need to establish local data collection and monitoring systems to track household resource allocation efficiency and well-being outcomes over time. Such systems can inform evidence-based policy interventions and allow for continuous improvement of household welfare programs.
